NO firearms, illicit or proscribed drugs, or alcoholic beverages from outside will be permitted at the festival site. All bladed weapons must be peace-tied, unless supervised by an appropriate vendor or organization member. Pre-approved forearms and blades for historic re-enactment groups are exempt.

NO vehicles, other than permitted carts, organizational vehicles, emergency vehicles, or those on display at the festival are allowed on the grounds for any reason during the festival hours of operation that the Festival and Games are open to the general public. NO exceptions, and this rule will be strictly enforced. Parking will be available at appropriately designated areas. Parking needed for the Hill Country Arts Foundation/Point Theatre operations will be left open at all times.
