The Hill Country Arts Foundation in Ingram, TX (west of Kerrville) is seeking artisans of all mediums to display and sell their handcrafted items for our exclusive 2018 ArtMart Exhibition featuring Indoor Holiday Gift Shopping. If you are looking for an outlet to sell your work over the holidays, we are the venue for you. And the best thing is ... You don't even have to be there.

As a participating artist, you will receive:

- A four week holiday sales venue with individual booths.
- Opening reception Nov. 16, 5pm-7pm.
- 3-ft deep x 8-ft wide individual booth space.
- After hour special invitations with selected evening events during the week.
- We handle the advertising and promotions.
- We handle the sales, you maintain your inventory.
- Set in an indoor art gallery decorated for the holiday season.

Booth and Rental Fee Conditions

Booth rental is \$50 per booth. Only two participants may share a booth at the regular booth fee. The exhibition is open during regular gallery hours (Tuesday – Saturday 10 am – 4 pm) and during specially selected evening events. Please keep in mind this exhibition is designed for holiday gift buying when selecting your wares to display. So price you items to sell!

**ArtMart at the Point is entitled to 30% commission on sales.
There is limited space available so contact us TODAY!**

Rules and Conditions

- Deadline for Entry is October 15, 2018. Entrance fees must be received on or before set up date.
- Booth set up and decorated with your wares November 12th. You will be assigned a booth number. Each item must be clearly labeled with the booth number first, as well as an item number, title, or description. Example: If you are booth number 1 and are labeling your first item, it would read #1-1, green wool hat. Jewelry may be marked with booth and item number only.

- Pick up unsold wares by 3 pm Monday, December 17. Show closes December 14.
- All items for sale must be made by the artisan exhibiting in the show. No imported merchandise will be accepted.
- No more than two participants can share a booth
- Participants must be at least 18 years of age.
- Checks will be issued to artisans for all completed sales transactions no later than December 19, 2018.
- Sales tax is collected by HCAF.
- All participants are responsible to set up their own booth, maintain their own inventory, disassemble and pick up their wares by 3 pm, Monday, December 17.
- HCAF encourages self-promotions through social media and your own email lists.
- HCAF does not provide insurance. Reasonable care will be taken during the handling of sales. HCAF has installed a security camera system, but is not responsible for loss or damage.
- Participants are responsible for decorating their booth in an aesthetically pleasing and professional manner.

ArtMart at the Point Artisan Contract 2018

All participants are subject to the “Rules and Conditions” guidelines. Booth rental fees must be paid in full by October 15, 2018. Participants will be refunded their entry fee in full upon a cancellation of the exhibition by HCAF. Otherwise, entry fees are non-refundable. All accepted participants are required to sign the contract clause with full payment of booth rental fee, otherwise, payment is not accepted.

Your signature is your bond and acknowledgement that you agree and accept all the rules and conditions to the exhibition guidelines as stated. In addition, upon your signature you authorize the reproduction of your work for promotional and advertising purposes for the exhibition.
