

# Fertile Ground: Annual HCAF Juried Show

'Landscapes of the Mind' This show is NOT limited to landscapes!

A call for entries is announced for the Hill Country Arts Foundation Juried Show.

Entry Fee: \$30 HCAF Members & \$35 Non-Members

**All work must be ready for gallery hanging. Please have all work tagged on the back, plus the information needed on the entry forms below.**

This exhibit has no predefined expectation for type or style of work to be considered or selected. Submissions can range from the most traditional to the most conceptual or experimental. All media accepted. Artists may submit up to three pieces of artwork for a hanging fee of \$30. With space allowing, all work submitted will be displayed. **Pieces must be framed or wrapped canvas. Please see HCAF policy below.**

Note: HCAF will not accept artwork that is NFS (not for sale) Artwork must remain on exhibit in the gallery between the start date and the end date of the exhibition for continuity and security considerations.

Installation and proper display: All work must be presented ready-to-hang, preferably with a wire attached to the frame. (Stainless steel braided picture wire works best for smooth hanging and deters rusting.) Framed artwork should have screw eyes or D-rings with hanging wire appropriate to the size and weight of the object. The use of tape, string, and wire to hang or secure an artwork into a frame is not acceptable. Be cautious about sawtooth hangers. They are not strong enough to support the weight of a frame safely. Large oils or acrylics on heavy-duty stretchers with a gallery wrap do not need to be framed. The canvas should be stapled on the back and the edge should be painted. When submitting three-dimensional artworks, HCAF will provide pedestals. However, HCAF has a limited quantity of pedestals available.
