Clans are provided a space on the Festival Grounds determined by the size of space requested and paid for by the vendor. Clans are responsible for their own canopy, tent or shelter, display fixtures, shelves, storage, tables, and chairs. Please be aware of any tree roots and other flora when staking your tent, help to protect and preserve the natural environment of the festival grounds. All vendors are responsible for collecting and paying Texas State Sales Tax as applicable to their product. Set-up

Clans may set up between noon and 6 p.m. Friday, April 26, or Saturday morning, between 7 and 9 a.m.

HOLD HARMLESS AGREEMENT

The Individual/Organization named in this form hereby agrees for itself, successors, and assignees, to indemnify and hold harmless the Hill Country Arts Foundation (HCAF) for all claims, lawsuits, and other actions for personal injuries, including death, and damages to property, real or personal, caused by your individual/organization, acts or omissions of HCAF, arising out of your individual's/organization's involvement in the Stonehenge Celtic Festival and Highland Games, and from all judgments and costs incurred in relation to said claims and lawsuits. SAFETY AND SITE RULES/POLICIES

NO firearms, illicit or proscribed drugs, or alcoholic beverages from outside will be permitted at the festival site. All bladed weapons must be peace-tied, unless supervised by an appropriate vendor or organization member. Pre-approved forearm and blades for historic re-enactment groups are exempt.

NO vehicles, other than permitted carts, organizational vehicles, emergency vehicles, or those on display at the festival are allowed on the grounds for any reason during the festival hours of operation that the Festival and Games are open to the general public. NO exceptions, and this rule will be strictly enforced. Parking will be available at appropriately designated areas. Parking needed for the Hill Country Arts Foundation/Point Theatre operations will be left open at all times.
